Introduction

- Self-reports suggest that more than 500,000 women are sexually assaulted in Canada every year
- In 80% of cases, sexual assault happens between people who know each other
- Between intimate partners, sexual assault can be part of an ongoing pattern of abuse

- The rate of survivors who report sexual assault to police is dropping – down to 5% in 2014
- 71% of survivors polled about reporting to police said the experience was negative
- Fear and/or lack of understanding about the law and legal system can be a barrier to getting help

- Knowing rights that a victim of crime has in the criminal justice system can help a survivor ask for support
- Canadian Victims Bill of Rights states rights to:
 - Information about criminal justice process and services
 - Protections considered, including security and privacy in court

- Canadian Victims Bill of Rights states rights to:
 - Participation to give views during the process
 - Restitution considered as a money payment from the offender to the victim
- ➢Ontario Victims' Bill of Rights, 1995
 - similar principles for the criminal justice system
 - ➢includes rights in civil court

- Ontario Victims' Bill of Rights, 1995
 ➢rights in civil court
 - person convicted of sexual assault or attempted sexual assault or spousal assault presumed to have caused emotional harm to the victim and responsible to pay damages

- Information about what to expect in the criminal justice system helps a survivor make an informed choice
- Information about other legal options helps a survivor choose what is best in their situation
- Elements of the criminal justice system can have a negative impact on survivors or "complainants" of sexual assault

Facts about the criminal justice system

- Police decide whether to lay a charge
- Crown prosecutor decides whether to go forward with a case
- Crown is not the lawyer for the complainant
- The complainant is a witness, not a "party"
- The complainant does not have a right to be represented by a lawyer in Court

Facts about the criminal justice system

- The complainant must testify, but can ask for other options
- The accused has the right to cross-examine the complainant
- The accused does not have to testify
- The accused is considered innocent unless the Court believes beyond a reasonable doubt that the accused committed the sexual assault

Independent Legal Advice

What does "independent" legal advice mean?

- the survivor is the lawyer's client
- lawyer represents only the survivor's interests
- conversations are confidential under rules of "solicitor-client privilege"

What is the ILA Program?

- 2 year pilot program in Ontario
- announced in March 2016
- Up to 4 hours of free legal advice for sexual assault survivors
 - ➤ survivors of all genders
 - ≻16 years or older
 - ➤ recent and past incidents
 - Sexual assault happened in Ontario
- No time limit to apply for advice

What is the ILA Program?

Sexual assault events covered by the ILA program include:

- unwanted sexual touching or sex
- the use of force, threats or intimidation to make you do something sexual that you do not want to do

What is the ILA Program?

- Operating in 3 locations in Ontario
 - Ottawa
 - Thunder Bay
 - Toronto (Barbra Schlifer Commemorative Clinic)
 - Only for woman-identified and non-binary genderidentified persons
- Information: 1-855-226-3904 (free)
 - 7days/24 hours

What is the ILA Program

- Ontario government-selected lawyers are available to give legal advice to survivors
- lawyers take a survivor-centred approach
- lawyers may discuss:

> how the law may apply in your case

> what facts are relevant

➤ your legal options

What is the ILA Program

- The ILA program will not pay for:
 ➤a lawyer to prepare legal documents for you
 ➤a lawyer to represent you in a legal proceeding
- If you can pay for a lawyer yourself, you may be able to continue working with the same lawyer who gave you independent legal advice

What kind of advice does the ILA provide?



What kind of advice does the ILA provide?

- things to consider when talking to police
- what can happen if you are going to criminal court
- the possibility of a human rights complaint
- how the Criminal Injuries Compensation Board works
- the possibility of a civil action (lawsuit)
- if there are relevant family law issues

What kind of advice does the ILA provide?

- making a complaint under a workplace policy
- whether your union might help you
- if there is a professional body that regulates members and has a complaint process
- how a university/college complaint process could apply

Questions to ask an ILA lawyer

- How does the law apply in your particular case
- What results are possible from each different legal option
- What is the process for reporting and what to expect, for each different legal option
- How different processes can (and can't) work together

Common Questions Discussed with an ILA lawyer

- This incident happened recently. Would this be considered sexual assault under the law?
- An incident happened several years ago. What might happen if I report it now? If I go to police will I have to go to Court?
- I have a case in the criminal courts, or at the Human Rights Tribunal, or another process. I don't really know what's happening, can you help me prepare?

How to Apply

- Get a voucher request form online
- Complete the form
- Form must be filled in by the person requesting legal advice
- Submit the form by email or regular mail
- You will get a reply:
 >by email in 3 days
 >by regular mail in 10 days

If you qualify for the ILA Program:

- you will receive up to four, 1-hour vouchers and a list of lawyers
- you can choose which lawyer to contact
- you can talk to a lawyer on the phone, or meet a lawyer in person
- you do not have to use all of your vouchers to pay for the same lawyer

- 1. A 16-year-old girl says that last year, her boyfriend's father touched her sexually. He said he would say she asked for it, if she told her boyfriend.
- 2. Your husband forced you to have sex on your honeymoon in Niagara Falls. You can't forget what happened. You are still married and living in Thunder Bay. You don't know what to do.
- 3. Your boss cornered you in your office, rubbed your body and said he would like to do more sometime. It happened in Windsor last year. You are living in Toronto now.

1. A 16-year-old girl says that last year, her boyfriend's father touched her sexually. He said he would say she asked for it, if she told her boyfriend.

Yes, the ILA can help a person who is 16 or older. It does not matter that the incident took place when she was younger than 16. She can contact the ILA any time after the incident happened.

2. Your husband forced you to have sex on your honeymoon in Niagara Falls. You can't forget what happened. You are still married and living in Thunder Bay. You don't know what to do.

Yes, the ILA can give advice to a person living in Thunder Bay. It does not matter that the incident happened in another Ontario location, or if it was a long time ago. It does not matter that the incident was with your husband or that you are still married. One of the options you may want to talk about with an ILA lawyer is how your family situation and legal rights may be affected by any other action you may take.

3. Your boss cornered you in your office, rubbed your body and said he would like to do more sometime. It happened in Windsor last year. You are living in Toronto now.

Yes, if you are living in Toronto, you can qualify for ILA advice about an incident of sexual assault that happened somewhere else in Ontario. The ILA will give advice about all types of unwanted sexual touching.
